These students may be incarcerated, pregnant and/or parenting, in foster care, expelled, chronically truant, in drug treatment, in group homes for neglected or abused children, and/or experiencing homelessness. Our programs give youth tools for positive self-expression and support their social/emotional and academic growth.

4b (Code: ) (Expenses \$ 355,915 including grants of \$ ) (Revenue \$ 312,067 ) Artist in Residence programs are 8 to 32 week partnerships with local schools. Teaching Artists instruct students in weekly lessons that are focused on discrete art or arts integration. Students learn a variety of art concepts, vocabulary, and techniques, while also cultivating imagination, critical thinking and other crucial life skills needed to succeed in todays world.

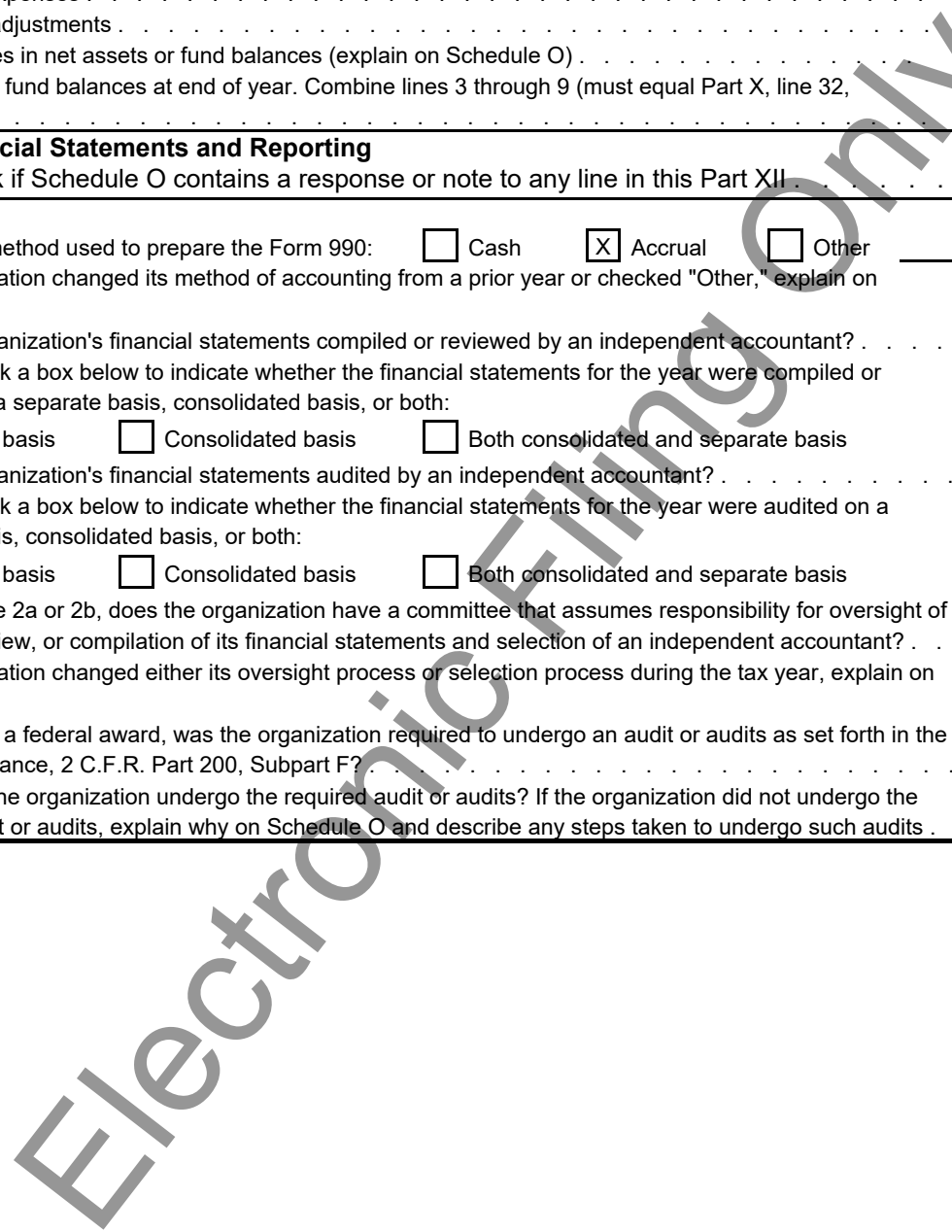
