These students may be incarcerated, pregnant and/or parenting, in foster care, expelled, chronically truant, in drug treatment, in group homes for neglected or abused children, and/or experiencing homelessness. Our programs give youth tools for positive self-expression and support their social/emotional and academic growth.

RESIDENCIES are 6 to 32 week partnerships with schools. Teaching Artists instruct students in weekly lessons that are focused on discrete art or arts integration. Students learn art vocabulary, techniques, and concepts, cultivating imagination, critical thinking, and crucial life skills needed to succeed in todays world.
